**Summary of Item:**

Council is in receipt of a application from the Brookton Country Club seeking funding from the Les McMullen Memorial Recreation Grant for the purpose of hosting the 2017 WA Golf State Sand Green Championships in August of this year.

The matter is presented to Council due to the limited timeframe, with the Officer Recommendation to endorse the application.

**Description of Proposal:**

This application respectfully seeks the maximum funding allowed (\$1,000) under the Les McMullen Memorial Recreation Grant Scheme to assist with costs in hosting the 2017 WA Golf State Sand Green Championships between 10<sup>th</sup> and 13<sup>th</sup> August 2017.

Specifically, the funds will be used for the hire of equipment associated with event, including toilet facilities.

A copy of the application is provided at **Attachment 11.07.17.01**.

**Background:**

The Les McMullen Memorial Recreation Grants Committee was established by Council in 1995, and has delegated authority to administer the bequest of the late Mr Leslie McMullen to the sporting community of Brookton. Applications were traditionally called from local recreation groups and organisations in February of each year, however, due to a poor response in recent years, the Council in June of this year resolved to vary the submission requirements allowing applications to be lodged at any time throughout the year.

As mentioned, applications would ordinarily be referred to the Les McMullen Memorial Recreation Grants Committee to be assessed and determined. However, due to time constraints with the 2017 WA Golf State Sand Green Championships occurring in mid-August 2017, this application is being referred to Council for endorsement so that the Brookton Country Club can progress with organising the event.

As the grant application reflects, the criteria set to receive funding includes a matching dollar for dollar contribution. Additionally, the funds are only allocated on:

- Purchase of sporting equipment
- Perpetual trophies
- Professional Coaching and training
- Sporting events of a significant nature
- Improvements to sporting facilities

**Consultation:**

There has been no consultation in relation to this matter.

**Statutory Environment:**

The Council is charged with the responsibility to administer the Les McMullen Memorial Recreation Grant program in accordance with the provisions of the Estate of the Late Les McMullen.

Section 5.16 and 5.17 of the *Local Government Act, 1995* affords Council the power to delegate its authority to a designated Committee of Council.

**Relevant Plans and Policy:**

There are no plans or policies applicable to this proposal.

**Financial Implications:**

There is no impost on the Shire's finances in relation to this matter, with the grant funding allocation held in Trust Account E990050 for this purpose.

**Risk Assessment:**

There is no perceived risk to the Shire in relation to this matter.

**Community & Strategic Objectives:**

This proposal generally aligns with the Shire of Brookton Strategic Community Plan 2013 – 2023 under:

*Outcome 1.4: A vibrant and inclusive community.*

*Strategy 1.4.1: Promote community and cultural events.*

**Comment**

It is apparent the application from the Brookton Country Club accords with a matching financial contribution and qualifies as a significant sporting event.

In regard Council determining the application, instead of the Les McMullen Memorial Recreation Grant Committee, it is suggested Sections 5.16 and 5.17 of the *Local Government Act, 1995* does not diminish the Council's authority to determine this application.

## Shire of Brookton Recreational Precinct



### **Locality and site map for construction of new cricket nets.**

Our current practise pitches are on the oval boundary and are in need of major repairs. The turf is old and worn, so needs replacing, while the netting has been vandalised and mowed over, also requiring replacement.

The surrounding netting needs to be constantly erected and removed depending on oval users and these pitches are not available to use during matches for practice hit up and bowling. The weight and size of these nets requires at least two adults to erect, also restricting junior usage.

The new nets will provide a permanent facility for batting and bowling practise on training days, game days and all year round. The western side net will be fully enclosed to allow for the safe operation of our bowling machine - containing balls within the net to protect the operator, other facility users and buildings. The eastern net will only be half enclosed to allow for spin bowling.

## Les McMullen Memorial Recreation Grants

### Who was Les McMullen?

Leslie McMullen was born in York in 1916 and was raised with four brothers and six sisters on a farm at Green Hills.

After working in the Brookton Post Office, he left to take up running the local TAB which he did until his retirement in 1978.

Les was a very keen sportsman involved with tennis, association cricket and golf. He was also an active committee member including being the handicap manager at golf for many years. There is still a championship trophy in his name.

Les was a returned WW2 soldier who was a very active member of the Brookton RSL having seen active service as a machine gunner in the Pacific.

It was known that his main passion was horse racing and he was a well-known identity in both the country and Perth racing circuits.

### About the Grants

Les very generously bequeathed \$43,000 to the Shire of Brookton to be held in trust for the benefit of all sporting bodies situated in the Brookton Shire. Initially the trustees of the estate, along with the Council Recreation and Building committee met annually to assess the applications. The current committee still includes two nominated community members passed along from the initial trustees.

Things happened more quickly back then – Les passed on the 9 August, the next Council meeting eight days later noted that the bequest had been made, and in September solicitors advised and Council accepted the bequest. By November formal guidelines were adopted and the first round of grants approved. Quite specific in his terms, these conditions still hold today.



### 2016 Grant Recipients

The Les McMullen Memorial Recreation Grants Committee met on the 19 May to consider the applications for 2016. All applications received were granted, including:

Brookton Tennis Club Inc  
\$330 Repair of nets

Brookton Womens Netball Club  
\$162.08 Nets, balls, first aid kit and bag

Brookton Auskick  
\$379 Jumpers and coaching course

### And Beyond....

After the 2016 grants there is still over \$6,500 remaining to be distributed in future rounds.

At its May meeting, the committee also agreed to introduce a second round of grants each year to assist clubs that are seasonal.
