Dog Act Registration Requirements

This registration is valid unless cancelled or refused pursuant to Section 16 of the Dog Act.

All dog licenses expire on the 31 OCTOBER.

All dogs aged three (3) months and over must be registered and microchipped.

A dog is exempt from the microchipping requirement if a Veterinarian issues a certificate stating that the implantation of a microchip may adversely affect the health and welfare of the dog.

At all times whilst in a public place, dogs must wear a current registration tag, together with an identification disc, with the name and address of the owner legibly endorsed or inscribed on or attached to the collar.

The Council where the dog is registered must be notified if any particulars contained in this application change.

A pensioner discount applies only to pensioners who are defined in the Rates and Charges (Rebates and Deferments) Act 1992.

To register your dog as a sterilised dog you must have proof of its sterilisation by either producing a certificate from a Veterinary Surgeon or by completing a Statutory Declaration Form.

This registration can be paid at the shire administration offices of your local council.
