Dog Act Registration Requirements

- This registration is valid unless cancelled or refused pursuant to Section 16 of the Dog Act.
- All dog licenses expire on the 31 OCTOBER.
- All dogs aged three (3) months and over must be registered and microchipped.
- A dog is exempt from the microchipping requirement if a Veterinarian issues a certificate stating that the implantation of a microchip may adversely affect the health and welfare of the dog.
- At all times whilst in a public place, dogs must wear a current registration tag, together with an identification disc, with the name and address of the owner legibly endorsed or inscribed on or attached to the collar.
- The Council where the dog is registered must be notified if any particulars contained in this application change.
- A pensioner discount applies only to pensioners who are defined in the Rates and Charges (Rebates and Deferments) Act 1992.
- To register your dog as a sterilised dog you must have proof of its sterilisation by either producing a certificate from a Veterinary Surgeon or by completing a Statutory Declaration Form.

This registration can be paid at the shire administration offices of your local council.
