## COVID-19 Case numbers

- As of **29 September 2020**, there have been **684** confirmed cases of COVID-19 notified in Western Australia (WA) and **34 historical cases**. **653** people have recovered.

## Living with COVID

### Message of the week – Keep up the physical distancing and good hygiene

Every Western Australian needs to play their part to help stop the spread of COVID-19. This means following good hygiene habits and physical distancing.

- **If you're sick, stay home.** Don't go to work, don't go to school, don't go out (except to get tested), and don't have visitors.
- **Keep 1.5 metres away from others** wherever possible.
- **Don't make unnecessary physical contact with others.** Avoid physical greetings, such as handshakes, hugs and kisses.
- **Wash your hands regularly** for at least 20 seconds with soap and water or an alcohol-based sanitiser.
- **Cover your mouth and nose when you cough or sneeze.** Use a flexed elbow or a tissue; if you use a tissue, dispose of it immediately and appropriately.

### Update - Patricia Oldendorff vessel

As of 29 September 2020, there are 17 confirmed COVID-19 cases amongst the crew from the Patricia Oldendorff vessel which is currently moored off Port Hedland. Seven of the cases are on board the vessel and 10 are in hotel quarantine. All crew members are in good spirits and have been able to contact family at home.

Planning continues with the vessel operator, the Australian Maritime Safety Authority and Pilbara Ports Authority regarding the safety of the vessel and potential replacement crew – if required.

The Department of Health, together with the WA Country Health Service, have reassured the Port Hedland community that every safety measure is being put in place to protect the maritime workers, emergency services and transport staff, hotel staff and the local community.

### School Leavers 2020 update

Due to the COVID-19 pandemic, the WA School Leavers program with organised events from Monday, 23 November through to Thursday, 26 November will take on a slightly different feel this year.

WA Police is working with partner organisations and the Department of Health on potential options for structured activities that comply with the relevant Directions and all other COVID-19 health requirements.

School leavers and parents are encouraged to download the free Leavers App, which will be updated with this year's information by 1 November. It will have all the latest information on events, getting around, and tips to stay safe.

## **Covid Event Plans**

COVID Event Plans are now required for any public or private event involving more than 500 patrons that also requires local government authority approval. COVID Event Plans must be approved by an authorised officer before they can proceed.

A COVID Event Plan will not be required for events that form part of the "usual business" of places for which there is an existing public building approval. These places will already have COVID Safety plans in place.

The COVID Event Guidelines and Plans will ensure event organisers play their role in keeping Western Australians safer, reducing the potential risk and spread of COVID-19, and giving event-goers more confidence to attend and participate in events.

## **International arrivals into WA**

Currently, 525 international arrivals are permitted to enter WA per week as part of a cap which was agreed to by the Commonwealth. At National Cabinet on 18 September, it was agreed the WA Government would work to lift the international arrival cap and get more Australians home.

WA will receive an additional 200 international arrivals from Monday, 28 September 2020. From Monday, 12 October, WA will take an additional 300 international arrivals per week. This will bring the State's weekly intake of international arrivals to 1025 people by Monday, 12 October.

## **New program to test wastewater for COVID-19**

WA's wastewater will soon be tested for COVID-19, with an evaluation program to expand PCR testing to the State's sewerage network. The Collaboration on Sewage Surveillance of SARS-CoV-2 (ColoSSoS) Project will track and monitor for traces of COVID-19 in WA's sewerage network. It will be led by WA Health, with testing undertaken by PathWest, to provide an opportunity for evaluation and review of the role of wastewater surveillance for COVID-19 in WA. Testing is expected to begin within the next month.

## Community

### Presentation for testing Direction

The updated [Presentation for Testing Directions \(No 5\)](#) has been released. In the updated Direction, people who must present for testing on day 11 (after arriving in WA) are now permitted to walk to and from a COVID clinic if it is located within 2km of their accommodation, provided they take all reasonable steps to stay 1.5 from other people while walking to and from the clinic.

### Residential Aged Care Facilities – Infection Prevention and Control Training

The Infection Prevention and Control (IP&C) team from the Public Health Emergency Operation Centre (PHEOC) have been supporting the State Health Incident Coordination Centre (SHICC) to provide training and practical demonstrations in the correct use of Personal Protective Equipment (PPE) and in the use of infection control practices in Residential Aged Care Facilities (RACFs).

Staff development nurses and nurse educators from the Area Health Services will be delivering this training across several RACFs over the next few weeks, with support from the PHEOC IP&C team, to assist RACFs in their COVID-19 preparedness.

### Changes to entry from Victoria and New South Wales

From Monday 5 October, people entering WA from Victoria will be able to self-quarantine, where possible, for 14 days at suitable premises, which will be assessed by WA Police as part of the G2G exemption application process. People entering from New South Wales will move to the same entry conditions that apply to other states and territories (excluding Victoria). The G2G NOW app will assist police with self-quarantine compliance. Use of the app is voluntary. Users will be instructed to take a selfie to verify their identity and location.

### DETECT Borders program

Weekly testing of WA border and hotel quarantine workers will run until the end of November. This program offers free, voluntary testing for frontline workers at COVID clinics in the metro and regional areas and aims to detect and prevent or limit community transmission of COVID-19. Some testing will be facilitated in affected workplaces to maximise participation.

People who fit the criteria for asymptomatic testing do not need to self-isolate after testing and can resume normal activities immediately. Negative results will be sent via SMS. Anyone who tests positive will be followed up in line with existing public health procedures.

## Testing

### General population [testing criteria](#)

Any person may be tested if they have any one of the following clinical criteria: fever ( $\geq 37.5^{\circ}\text{C}$ ) OR history of fever (e.g. night sweats, chills), without a known source **OR** an acute respiratory infection (e.g. shortness of breath, cough, sore throat, runny nose) **OR** acute loss of smell or taste.
