  - Executing a 12 month Residential Tenancy Agreement at the rental set in Council's Fees and Charges for this unit, and a condition assessment report being completed prior to occupancy occurring;
  - b) Paying the required bond monies of 4 weeks rent to be placed in trust with the Department of Mines, Industry Regulation and Safety, and 2 weeks rent in advance.
- 2. The application received from Mr Mervyn Stokes to occupy a Senior Citizen Unit No.1 at 33 Whittington Street Brookton, subject to the tenant:
