5.06.21.01 DRAFT MOU – EMERGENCY RESOURCE SUPPORT – BEVERLEY/ BROOKTON/ PINGELLY/ WANDERING

The Shire CEO to follow up with Shire CEO's as there has been no response regarding the agreement of the MOU.

5.06.21.02 HAPPY VALLEY WATER AVAILABILITY FOR FIRE FIGHTING/STOCK WATERING

The Shire CEO advised that the Shire is still investigating increasing the storage capacity of Happy Valley Water (another 200,000L tank), at the current location adjacent to the sewerage ponds to ensure availability during times of emergency.

The Shire CEO advised that that a tank will be placed down there, if not funded by grants, the Shire budget to be an alternative contingency. Also outlined was the need to identify water resources throughout the rural and remote areas within the Shire.

6.06.21.02 COMMUNITY EMERGENCY SERVICES MANAGER (JASON CARRALL) REPORT

Shire of Brookton – 9th March to 1st June 2021

- Completed my Mental Health First Aid course. This was very informative and highly recommend others to undertake the course.
- Currently in process of organising and delivering BFB Skills Courses. This will take place over the next 6 months.
 - FCO's
 - Ground Controller
 - Bushfire Safety and Awareness
 - Firefighting Skills
 - Farmer response (when Available)
- Assisted DFES in mitigation burn on UCL land in town. We had Brookton Central and Pingelly LT assist as well as Paul Dennison, Blake Halford and Sandie Spencer. We managed to complete 70% of Burn area with difficulties finishing remaining 30% due to weather conditions.
- After successful meetings with ARC infrastructure planning went into place to start working with ARC to reduce the risk on the railway lines. Unfortunately, ARC have put all works on hold due to Management Change within the organisation. I will continue to liaise with ARC to try keep the program moving forward in a positive way.
- Saturday 24th April assisted with community engagement event in Pingelly. Huge success and looking to holding more in the future hopefully in Brookton and Corrigin.
- Successfully negotiated with DEFS to have an extra \$10,000 over expenditure for PPE for our volunteers form the ESL. This order has been placed and waiting for it to arrive.
- Went on deployment to Geraldton to assist with TC Seroja. Was a busy week but enjoyed it and gained some good experience in working within a big Incident.

The Animal welfare plan was adopted by council and I want to thank Sandie Spencer for her hard and dedicated work to make this happen.
