# 4.09.17 CORRESPONDENCE

Letter reiterating Harvest and Movement Ban exemption cancellation to Balco Australia Pty Ltd sent 13/09/2017. Attachment 4.09.17.01

DCBCO Travis Eva advised Balco Australia Pty Ltd, Brookton site, representatives have now raised concerns with the impact of revocation on business operations that was not foreseen as at March 2017 meeting.

Bushfire Advisory Committee discussion resolved that exemption revocation was due to noncompliance and, as directed in the relevant correspondence, Balco Australia Pty Ltd can take the actions required to meet the criteria specified for compliance to the satisfaction of the Chief Bushfire Brigade Officer, Murray Hall and reapply for exemption.

# 5.09.17 REPORTING

# 5.09.17.01 CHIEF BUSHFIRE CONTROL OFFICER

Welcome to Shire President Katrina Crute, CEO Ian D'Arcy, DFES representative Paul Blechynden, Captains, FCO's and BFAC committee members.

Not a lot to report during the winter months since last BFAC meeting except items of business from that meeting.

The fuel growing season has been turbulent as an understatement. We will (as a farming district) thankfully have reasonable crop fuel loads but broken up with very low Pasture fuel loads. The bush land will be as high as ever with good growth throughout the wet autumn period.

Shire of Brookton – Unconfirmed Bushfire Advisory Committee Meeting Minutes 14th September 2017

The Captain's, Sharyn and I have had a couple of working group meetings to update the Brigade contacts lists and then now onto updating the DFES data base to check that all members have their DFES volunteer numbers. This is an onerous task as there has been a couple attempts at completing this task and Sharyn has had to merge and archive several documents. From this we have some 36 contacts to update with DFES and is under way.

Updating forms have been distributed to captains to gather further required information. I would like to see this information "versioned" annually and signed off at AGM. This will lead to updating SMS lists and finally the Shire resident's maps. These lists are also important to the LEMC

A big thankyou to the current Administration on recognising the importance of all this and affording the all-important staff time.

I would like to thank the Council for finally giving a moderate discretionary spend of \$500.00 for the CBFCO and DCFCO. This officially gives an out of office hours starting spend limit in a fire event for water and supplement for fire fighters. There are strict conditions and are at the discretion of the CBFCO and DCBFCO who then are responsible.

The trucks have all now been serviced with central tender needing a visit from IZUZU Perth to remedy an oil leak on the motor.

All the AVL units are in place now. A short course on this is planned at the end of the meeting. We have been offered two of the AVL units to install in other assets. Maybe a Grader or Loader.

Attended DPAW meeting in April 2017. Advised work to be done on firebreaks in WEAM reserve.

Back burning Lupton Reserve has had some attention but burn hindered by weather.

High fuel loading area Strange Rd process started to add to DPAW burn list for 2018. Radios -The works department have added 4 non WAERN radios to the fleet to enable us to better communicate.

The Shire vehicle radio fleet include:

- Works Supervisor vehicle
- Water truck x 1 plus 1 tentative water truck
- Small truck
- Graders x 1 WAERN
- Loader WAREN

This is a welcome improvement as these machines are critical assets in a lot of incidents. If there is ongoing reliability with these simpler radios it may lead to the WAERNS being relocated to more FCOs.

I have had communication with all surrounding Chiefs and have checked dual fire fighters.

Shire of Brookton – Unconfirmed Bushfire Advisory Committee Meeting Minutes 14th September 2017

The main change is a new Corrigin chief with Greg Evans replacing Wes Baker. And a new dual FCO in Brayden Grylls. Captains please note these changes in your updated season packs.

I have made the point to all Chiefs the changes in our Fire Break Orders. Wandering is currently reviewing theirs due to some perceived ambiguities. Sound familiar?

East Brigade has had a hands on day for member training last month. West Brigade hands on is upcoming next month.

In closing I would like to thank all the various contributors to this service. Not limited to: Shire Admin, Shire works, Captains and secretaries, FCOs, Brigade members, their employers and brigade member partners, radio base operators and DFES.

- Training program is drawing to a close as we approach bush fire season.
- A preseason session meeting has been organised for:
  - a. Pingelly (Saturday 7 October 2017, 10am at the Pingelly Fire Station) please let me know of those who may be interested for catering (BBQ)
  - b. Narrogin Tuesday 10 October from 10am 2pm at the Narrogin DFES office.

The program includes desk top bush fire exercise stepping through the tasks and decisions you may face. Also available is demonstrations on how brigade members can access the tracking information and get the most from the Automatic Vehicle Location (AVL) units as well as an early mapping feature.

- I'm also keen to help shires with refreshers on:
  - a. Crew protection systems deluge system, curtains, in-cab air discuss or practice burn over
  - b. Radio refresher both using the radios and how to get the most out of the radio channels (avoid overloading a channel)

Action: Training October 18th - Ground Controller course 8am start, finish 2.30pm Wednesday Radio and Truck operations run through 4pm start. Extend invitation to Pingelly BFB and VFRS. Shire staff Toolbox style basic run through between 2.30pm to 4pm to be confirmed.

- Portable AVL units are available, noting that monthly maintenance is required to ensure that the units can receive software updates. I can provide a quick demonstration at the end of the meeting via power point if required.
- DFES mapping. Shire Map available.
